• Income: Dues 2023, Christmas Party 2022, John Engler Carving & Painting Seminar, Floyd Rhadigan Seminar, and John Overby Seminar

- A motion was Dick Fleisner and seconded by Ron Peters to approve the treasurer's report. All in attendance agreed.

Old Business:

- **Christmas Party:** Ken Brzezinski reported that (54) members had signed up for the Christmas party, but only (49) attended either due to the weather or health conditions.
