#### **Upcoming Seminars**

John Engler of Battlefield, MO will be conducting a (3) day woodcarving class (Tuesday, Wednesday, & Thursday August 22, 23, & 24, 2023) and a (1) day painting class (Friday August 25, 2023). He is very active in teaching relief carving and watercolor painting throughout the U.S., as well as operating the John Lee Engler and Associate design studio.
